Partnering with FOHMP to secure third party funding, Kylie and Margaret developed A Healthy Living Initiative at Hybla Valley Elementary School for potential at-risk students. This eight week active outdoor environmental and art program at HMP provided education, program supplies, and transportation at no cost to the students or school. Most participants had never visited the Park, and observers could see their excitement during each week's session. Staff report the children's spoken gratification and smiles said it all for them.

Dave conducted rare bird surveys by leveraging technology to reduce field hours by 95%. He worked with the FOHMP to secure a grant for this technology. Dave took a lead role in a Huntley/Department of Public Works and Environmental Services stormwater project in Hayfield, Alexandria, Va. The project continued on schedule through COVID, and Dave worked cooperatively to resolve project issues. Dave also completed dissections to support the Fairfax County Police Department deer Chronic Wasting Disease testing. Dave is an outstanding steward for FPCA and HMP!

Annual Bird-a-thon and Beyond!

2021 will see the 25th Bird-a-thon Friends of Huntley Meadows Park (FOHMP) has hosted to raise funds to support the Park’s summer Resource Management (RM) Intern. For 23 years, the counting of birds at Huntley Meadows Park (HMP) was done solely by a select group of birders on one morning in May. The 2020 Bird-a-thon coincided with the closure of Fairfax County Parks due to the COVID pandemic, causing the FOHMP Board to rethink how to conduct the annual event. The FOHMP Board decided to change the event to Bird-a-thon and Beyond! We invited everyone to join us in counting the birds in their back yards or neighborhoods for a week in early May. The final tally was then posted on our website, <http://fohmp.org/>.

The Board of FOHMP had so much fun seeing the results come in from those who birded with us. We think our friends also had fun joining in the count. So, this year we will again be asking our friends to bird with us in your back yards, local parks, or other locations. After the count is over email friendsofhmp@gmail.com with a list of where you watched, how much time you spent counting birds at that location, the bird species you saw and number of each. We will create a full tally of the bird species sighted.

Please do your count anytime between May 1 and May 7, 2021. The usual group of birders will return to count in the Park during this same week, following all guidelines in place to prevent the spread of COVID-19.

If you don’t count any birds, there is another important way that you may contribute - you can make a donation. As always, the Bird-A-Thon is also a fundraiser that supports the Park’s RM Intern. Over the years, many on the Board of FOHMP have had the privilege of interacting with the interns in this position, and we all believe they have helped the Park tremendously through assistance with land stewardship and conservation. Additionally, this internship provides a young person with needed hands-on experience as he or she begins a career in conservation.

Sophia Chapin said of her time as the 2020 RM Intern, “Working at HMP has reminded me of all the reasons I want to work in conservation. I am excited to apply the skills I learned during my time at HMP identifying species, collecting and analyzing data and composing reports into my studies at the Smithsonian Environmental Research Center in Front Royal this fall.

The Challenges of Increased Park Usage: During the pandemic our local parks have seen large increases in visitation, as more people seek out nature for relaxation and enjoyment. While this reinforces the importance of parks and green spaces to our society, there are management challenges to having more visitors. To avoid degrading our parks and unduly disturbing wildlife, visitors need to follow park rules by staying on the marked trails, not littering, and keeping bikes, scooters, skateboards, strollers, and pets out of the areas where they are prohibited. We, experienced nature-lovers, can help by following the rules at HMP and any other parks we use.

Budgetary Implications: As a result of the pandemic, spending priorities have shifted towards emergency funding areas; other budgets have been slashed, and support services are strained. This shift of resources has unfortunately resulted in less funding for many Fairfax County parks and natural areas, including HMP. The severe disconnect between the importance of natural areas and how they are funded has become even more glaringly obvious during the pandemic. One way to help reduce this disconnect is for more of us to advocate for adequate funding for proper management of our natural resource areas. The next series of budget hearings at which we can advocate for more funding for FCPA parks is coming this spring. Stay tuned for the timing of these hearings. Each of us can take action by providing testimony.

Project and Policy Decision-making: Some political leaders and decision-makers may use the pandemic as an opportunity to push through policy changes with a reduced public consultation process due to the “emergency situation.” Just because we have a public health emergency, this should not translate to a “free pass” to overlook the environmental impact of development projects and the need for appropriate mitigation actions. Accordingly, our advocacy on behalf of parks and other natural areas is even more important during this pandemic.

Research Projects and Invasive Species Management: Some field-based research and management projects have been deferred due to the pandemic physical distancing requirements and our inability to meet in person. Data collection and monitoring to inform scientific research may have a gap period or gap year with incomplete data. Invasive plant removal projects have restarted in Fairfax County but, with COVID restrictions in place, some volunteers are hesitant to participate. As a result, this could be a banner year for unchecked invasive plant growth. The next few years will require extra volunteer effort to catch up.

These are some of the pandemic’s impacts; there are, of course, many more depending on your perspective. It is especially important to learn from the impacts each of us experiences, so that we can plan a new way forward. With the new federal administration, there will also be changes and opportunities beginning in 2021. Let’s all do what we can to bring about positive changes with the new way forward. I eagerly await timely and successful COVID-19 vaccinations so that all of us can be around our families and friends again, as early as possible in 2021.

I hope to see you on the trails really soon!


